Cozy Quarters Pet Inn Boarding Agreement

This is a Contract between Cozy Quarters Pet Inn (hereinafter called "Kennel") and the pet owner, _____, whose signature appears below (hereinafter called "Owner") for services for _____ (hereinafter called "Pet(s)").

- I. **Kennel** agrees to exercise due and reasonable care to keep the kennel premises sanitary and properly enclosed. The **Pet(s)** is to be fed properly and regularly, and to be housed in clean, safe quarters. All **Pet(s)** are cared for by **Kennel** without liability on its part for loss or damage from disease, death, theft, fire, injury to persons, other animals, or property by said **Pet(s)**, or other unavoidable causes, due diligence and care having been exercised. The **Owner** agrees to be solely responsible for any and all acts or behavior of said **Pet(s)** while it is in the care of the **Kennel**. **Owner** agrees to be financially responsible for kennel property damaged by **Pet(s)**. Reasonable costs for damage will be payable upon checkout of **Pet(s)**.
- II. Payment is expected for services at the time of checkout. **Owner** agrees to pay the rate for boarding in effect on the date **Pet(s)** is checked into the **Kennel** as posted on the **Kennel's** website/in store. **Pet(s)** picked up after ten o'clock in the morning (10:00AM) will be charged the full boarding rate for that day. **Owner** agrees to pay all costs and charges for special services requested, plus all veterinary expenses deemed appropriate by **Kennel** for **Pet(s)** during the time **Pet(s)** is in the **Kennel's** care. **Owner** hereby consents if any charges for boarding, medicine, or veterinary services are not paid within ten (10) days after they are due or if said **Pet(s)** is not called for within five (5) days after scheduled date of pick up, then a certified letter or registered letter will be mailed to the **Owner** of said **Pet(s)** at the address given, giving the **Owner** ten (10) additional days to claim the **Pet(s)** and pay any outstanding charges, or the **Pet(s)** will be considered abandoned and thus be placed with the Humane Society or with the local dog officer as an abandoned animal(s).
- III. **Owner** agrees that **Pet(s)** has not been exposed to rabies or distemper within a thirty (30) day period prior to boarding and vaccinations are up to date. **Kennel** requires proof of current Rabies, Distemper and Bordetella vaccinations. **Kennel** cannot be held liable if vaccinated **Pet(s)** contracts Kennel Cough. If **Pet(s)** becomes ill or if **Pet(s)**'s behavior is endangering itself, humans, or other animals, **Kennel**, in its sole discretion, may engage the services of a veterinarian. All attempts will be made to contact the **Owner** of the **Pet(s)** first; however, in the event of an extreme emergency, the well being of the **Pet(s)** comes first. Medication will be administered as necessary under the direction of a veterinarian. The undersigned **Owner** hereby gives the veterinarian complete authority to treat **Pet(s)** in whatever manner deemed necessary. As previously stated, **Owner** will be responsible for all veterinary charges upon release of the **Pet(s)**. **Owner** also gives full authority for the treating veterinarian and their associates to discuss with **Kennel** any aspect of any illness or injury that the **Kennel** has presented for treatment.
- IV. **Owner** authorizes **Kennel** to use pictures of **Pet(s)** taken while participating in **Kennel** activities on its website and in other promotional materials.
- V. By signing this Agreement and leaving **Pet(s)** with the **Kennel**, **Owner** certifies to the accuracy of all information given about **Pet(s)** to the best of their knowledge and has read and accepted all policies listed in this agreement.
